Supervisor Skibbe called the meeting to order at 11:00 a.m., followed by the Pledge of Allegiance.

ROLL CALL

CLERK APPOINTMENT

Supervisor Nathan Skibbe informed the board of the process in which the Personnel Committee has advertised and interviewed for the new Clerk appointment. All applications were provided to the board for review. Moved by Trustee Cash Kroll and supported by Trustee Norm Poli to appoint Michele Palevich as the new township clerk effective Monday, September 10, 2018 at 12:01 p.m. Roll call vote was taken: AYES: Trustee Nate Thomson, Supervisor Nathan Skibbe, Treasurer Laura L. Ellery-Somers,

Trustee Cash Kroll and Trustee Norm Poli. NAYS: None. Excused: Clerk Karie K. Bleau and Trustee Matt Dunckel. Motion carried.

PUBLIC SAFETY FUND WORKERS COMPENSATION INSURANCE

Treasurer Laura Ellery-Somers informed the board that the Public Safety Fund did not have enough money in its cash account to pay its portion of the workers compensation insurance invoice in the amount of \$44,853.67 in August. Funds were paid out of the general fund and when public safety millage revenue is received beginning in the month of December the general fund will be paid back.

Moved by Trustee Nate Thomson and supported by Trustee Cash Kroll to approve the Public Safety Funds workers compensation insurance invoice to be paid out of the General Fund in the amount of \$44,853.67 and that the Public Safety Fund will pay back the General Fund after millage revenue is received in December.

PUBLIC SAFETY FUND MONTHLY APPROPRIATION

Treasurer Laura Ellery-Somers informed the board of the need to transfer three of the monthly appropriations from the General Fund into the Public Safety Fund in the amount of \$19,883.83 \times 3 months = \$59,651.49 (August appropriation was transferred on 7-17-18, September appropriation was transferred on 8-1-18 and the October appropriation was transferred on 8-28-18). This was necessary to do as the monthly expenses were more than revenues. The Public Safety Committee will meet with the Fire Chief to discuss finances in the near future

Moved by Trustee Nate Thomson and supported by Trustee Cash Kroll to approve the transfer of funds for the months of August, September and October monthly appropriations from the General Fund into the Public Safety Fund in the amount of $$19,883.83 \times 3 \text{ months} = $59,651.49$.

Ellery-Somers, Deputy Treasurer Rhonda Himes and Clerk Michele Palevich be authorized to execute new bank deposit resolutions with PNC Bank, Chemical Bank and MBank, naming the Charter Township of Alpena Treasurer and Clerk and their deputies as authorized agents. The Deputy Clerk is yet to be determined.
