Todd Spigelmyre was in attendance to address this case. He brought in a revised version of the plan. The new plan shows the water retention areas and the added landscaping. Marie Twite asked if it met the 10 year design for storm retention and it did. C. LeFebvre asked about the maintenance of retention areas. T. Spigelmyre expressed the need to keep the areas up.
